The Property Registration Authority (PRA) is the State organisation responsible for the registration of property transactions in Ireland. The main function of the PRA is to maintain the integrity and reliability of the Register and also to promote and drive the extension of the Register.

What is the Land Registry?

The Land Registry maintains a register of legal interests in property, such as ownership and mortgages, which is conclusive evidence of title to property and is guaranteed by the State. Registered land parcels are recorded on a document known as a Folio. Since 2011, once a property is sold in Ireland, the title must be registered on the Land Register.
