1. General

Customers may request a 'spatial query' to be carried out on their behalf or order an electronic extract from the Registry's digital vector map (through the Spatial Information Unit).

There are three methods for ordering spatial data/electronic extract of Land Registry vector geometry.

Customers can:-

1. Provide a Folio number or list of Folio numbers.
2. Supply a list of Registered Owner names (for Property Interest Registers only).

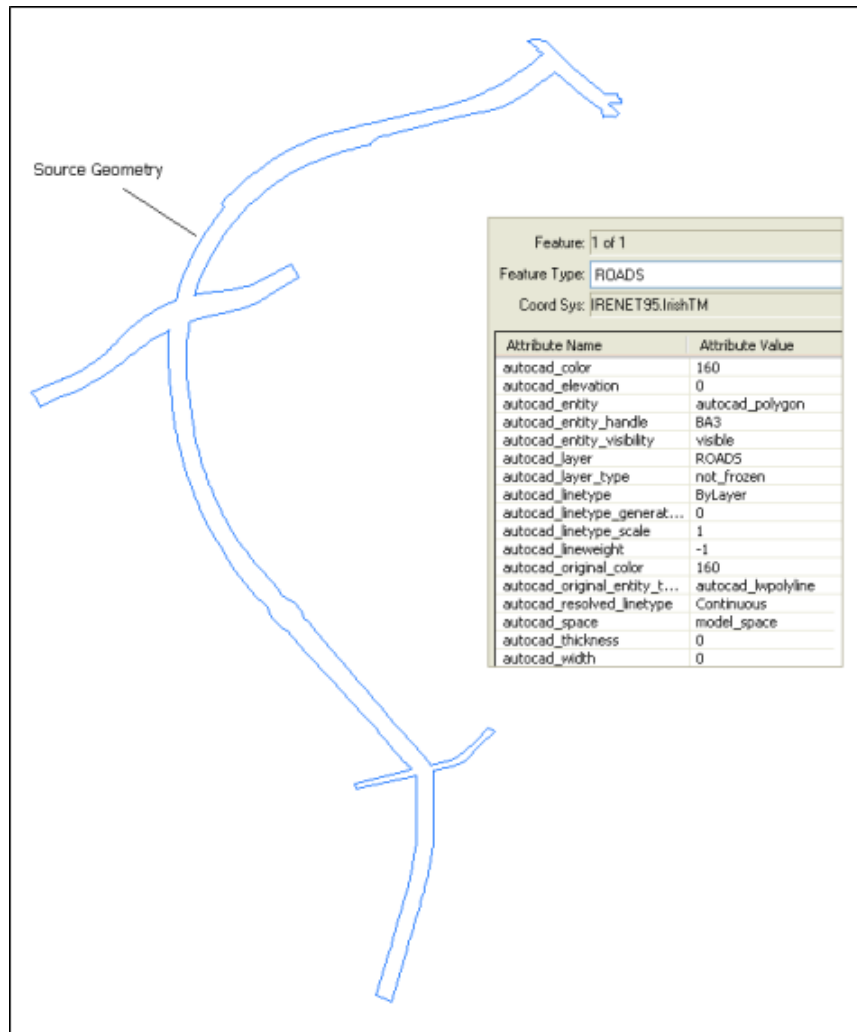


Figure 1 - Source Geometry

3. Provide source geometry in the form of a polygon representing the route or area to be searched (Fig 1).

The source geometry must:

- Form a closed polygon. The preferred format is GML (**G**eography **M**arkup **L**anguage), however other geometry formats may be accepted such as CAD/Shapefile.
- Reference the Irish Transverse Mercator (ITM) coordinate system. Geometry submitted referencing Irish Grid (IG) coordinates will not be accepted.

1. Making an application

Applications to the PRA data extracts may be made on the application form pursuant to one of the following methods depending on the applicant's eligibility:

- 1. Land Registry Fees Order 2012 (Schedule Item 22).**
- 2. PSI Regulations S.I. 525/2015.**
- 3. Other Specific Statutory provision.**

Further information on each of the three methods can be found on the application form.

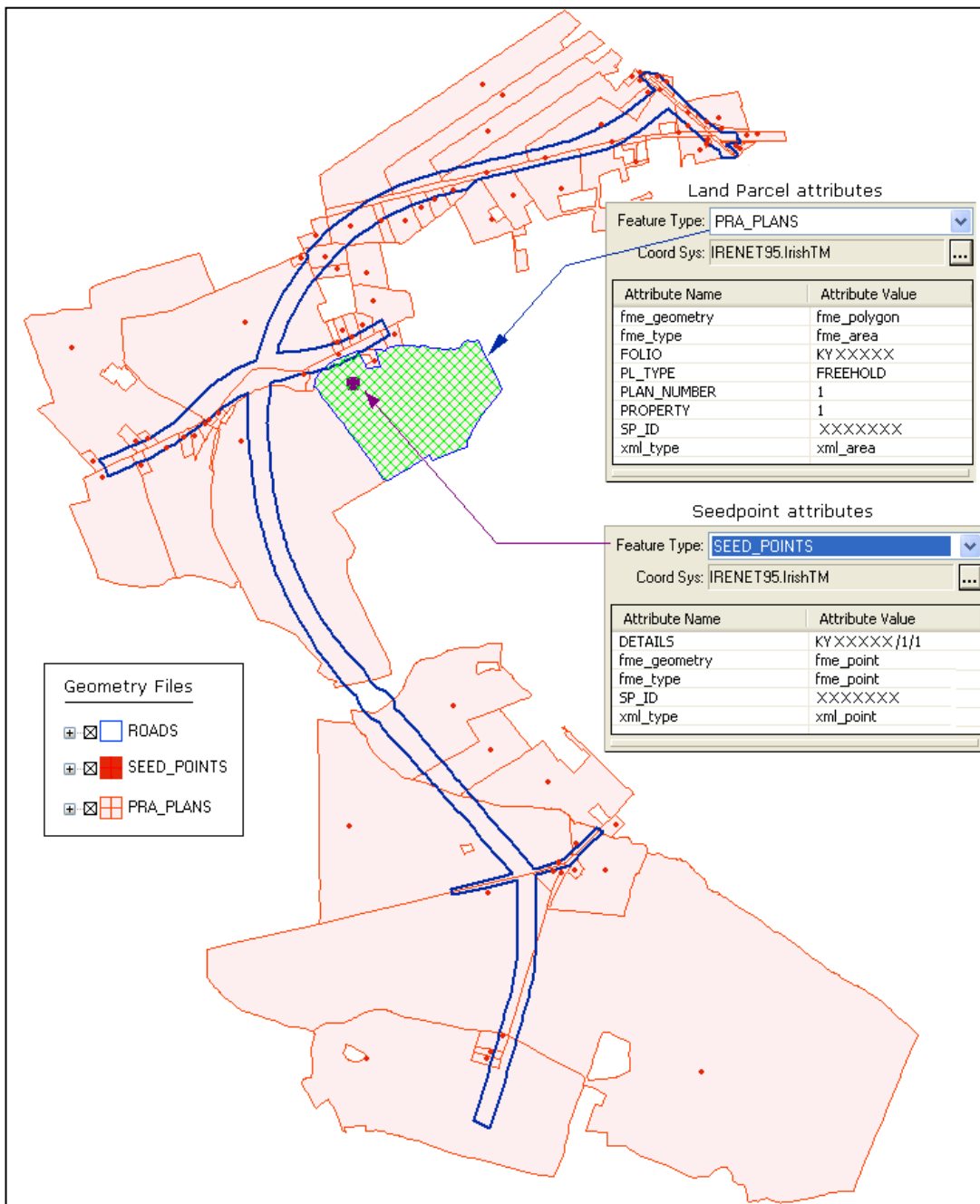


Figure 2 - Output Parcel GML & Seedpoint GML files with source geometry overlaid.

The output from the spatial query will consist of files comprising parcel and seedpoint geometry (Fig 2) together with a **CSV** file (Fig 3).

Area Burdens, Line Burdens and Point Burdens (see Mapping Guidelines Appendix 9) will not be included as part of the output from a spatial query unless specifically requested at the time of application.

The map output format will be GML (**G**eography **M**arkup **L**anguage). GML is the format recommended in the INSPIRE directive for exchange of Spatial Data). Other geometry formats can be produced on request.

The CSV file will consist of an extract of Folio attributes for the parcels that are included in the GML extract:-

- Folio
- Prop_Num
- Plan_Number.
- Owner_ Name(s) Currency of owner name is dependent on the timing of applications being lodged to update the Register
- Appl_Num. Lists applications pending (if any) against Folios
- Addr This is the address for service of notices in the state
- Seed point X and Y ITM coordinates
